Fostoria City	Authority to Aggregate Retail Electricity Loads Electricity Aggregation Program.
Northwood City	Ordinance by petition Shall the City of Northwood adopt the sensible marihuana ordinance?
Perrysburg City	Replacement, 1 mill, 2 years, commencing in 2019, first due in calendar year 2020. Collection and disposal of garbage and refuse.
Rossford City	Additional; 2.8 mills, 5 years, commencing in 2019, first due in calendar year 2020. Providing and maintaining fire equipment, apparatus, appliances, buildings or sites to operate a fire department.
Rossford City	Additional; 1 mill, 5 years, commencing in 2019, first due in calendar year 2020. Payment of permanent, part-time, or volunteer firefighting, EMS & administrative personnel to operate a fire department.
Rossford City	Additional; 1 mill, 5 years, commencing in 2019, first due in calendar year 2020. Recreational purposes.
Rossford City	Additional; 1 mill, 5 years, commencing in 2019, first due in calendar year 2020. For operation of parks.

Township

Bloom Township	Replacement; 1.0 mill, 5 years, commencing in 2019, first due in calendar year 2020. General construction, reconstruction, resurfacing, and repair of streets and roads.
Center Township	Additional; 1 mill, 4 years, commencing in 2019, first due in calendar year 2020. Fire department operating expenses and purchasing fire apparatus.

Freedom Township	Renewal; 1 mill, 3 years, commencing in 2019, first due in calendar year 2020. Current Expenses.
Grand Rapids Township	Additional; 0.25 mill, 4 years, commencing in 2019, first due in calendar year 2020. Providing funds to maintain and operate Beaver Creek Cemetery.
Jackson Township	Renewal; 0.75 mill, 2 years, commencing in 2019, first due in calendar year 2020. Providing and maintaining fire apparatus, appliances, buildings, water supply and materials, payment of volunteer firefighting and admin personnel.
Middleton Township	Renewal; 2 mills, 3 years, commencing in 2019, first due in calendar year 2020. Providing, maintaining and operating the Middleton Township Fire Department.
Perry Township	Additional; 0.5 mill, 1 year, commencing in 2019, first due in calendar year 2020. Emergency Medical Services.
Plain Township	Replacement; 2.0 mills, 5 years, commencing in 2019, first due in calendar year 2020. Fire protection and emergency protection.
Weston Township	Additional; 1.5 mills, continuing period of time, commencing in 2019, first due in calendar year 2020. Purpose of providing fire protection.

Village

Bradner Village	Renewal; 0.7 mill, 5 years, commencing in 2019, first due in calendar year 2020. Maintaining and improvement of village park land.
Custar Village	Renewal; 2 mills, five years, commencing in 2020, first due in calendar year 2021. Current Expenses.
Haskins Village	Renewal & Increase; 2.5 mills, 5 years, commencing in 2019, first due in calendar year 2020. Street construction and reconstruction.
North Baltimore Village	Renewal; 2.0 mills, 5 years, commencing in 2020, first due in calendar year 2021. Street and road construction, reconstruction, resurfacing, and improvements.
Risingsun Village	Renewal; 1.8 mills, 5 years, commencing in 2019, first due in calendar year 2020. Purchase and maintenance of fire and medical protection equipment.
Risingsun Village	Renewal; 1.3 mills, 4 years, commencing in 2019, first due in calendar year 2020. Current expenses.

Risingsun Village	Additional; 2% income tax General municipal operations, maintenance of equipment, extension, enlargement and improvement of municipal services, facilities, and capital improvements and for bond retirements.
Risingsun Village	Renewal; 0.5 mill, 5 years, commencing in 2019, first due in calendar year 2020. For operation of parks.
West Millgrove Village	Authorized to reduce the number of village Council from six members to five members Authorize council to reduce the number of members from six to five members.
West Millgrove Village	Renewal; 5 mills, 5 years, commencing in 2019, first due in calendar year 2020. Current Expenses.

School Districts

Bowling Green City School District	Income Tax and Bond Issue; 1/4% Income tax, 1.6 mills, \$20,000,000, 30 yr Bond. Constructing an elementary school; renovating and improving existing facilities if funds are sufficient therefor; furnishing and equipping the same; and improving the sites thereof.
Eastwood LSD - Pemberville Library	Renewal; 0.8 mill, 5 years, commencing in 2019, first due in calendar year 2020. Pemberville Public Library; Current Expenses.
Perrysburg Exempted Village School District	Additional; incremental 7.9 mills to 14.2 mills, commencing in 2019, tax not levied after 2023. Current Expenses.

Other

Henry Township Fire District	Renewal; 1.5 mills, 5 years, commencing in 2019, first due in calendar year 2020. Fire Protection.
Henry Township Fire District	Renewal; 1.2 mills, 5 years, commencing in 2019, first due in calendar year 2020. Provision of ambulance, paramedic, or other emergency medical services.
Henry Township Road District	Renewal; 1 mill, 5 years, commencing in 2019, first due in calendar year 2020. Road repair, improvement, and maintenance.
Mid-County Ambulance District	Replacement of 2 existing levies - reduction of 1 mill to 4.5 mills, 3 years, commencing in 2019, first due in calendar year 2020. Providing funds for ambulance service and emergency medical services.
