Any voter that wishes to vote prior to election day may do so by two different methods:

- By mail - the request must be made in writing and include the Voter's name, address of voting residence, address the ballot should be sent to if different from voting residence, date of birth, identification information (last 4 digits of Social Security Number **or** Ohio Driver's License Number **or** a copy of one of the following forms of identification: current and valid photo ID, a military ID, or a current (within the last 12 months) utility bill, bank statement, paycheck, government check, or government document (other than a notice of voter registration mailed by a Board of Elections) that shows your name and current address. Finally, a statement indicating you are a qualified elector and wish to have a ballot for November 8, 2022 sent to you.
- In person at the Board of Elections during regular business hours. Contact the Board of Elections for date/times that in person voting is available.
