WHEREAS, on January 16, 2019, County Administrator authorized a Plan Amendment 1-19 for the Wood County Employee Health Benefits Plan documenting the pre-certification of prescription drugs that are \$2,000 or more of high cost injectables and infusions received under the medical benefits, and

WHEREAS, it is necessary to correct the amendment to reflect the value that is documented in the Plan Document which is \$1,000, which is documented in the Plan Amendment 22-01, and included as Attachment A, and

WHEREAS, the Board has considered the recommendations to correct Plan Amendment 19-01 and to authorize the Plan Amendment for proper administration of benefits and concur with said recommendations; therefore, be it

RESOLVED, by the Board of County Commissioners of Wood County, Ohio, that all said language be updated in the Wood County Health Benefits Plan Document as listed in Attachment A which reflects the correct value of \$1,000 for pre-certification of high cost injectables and infusion; and be it further

RESOLVED, that Plan Amendment, Attachment A, is hereby authorized for proper administration of the Plan and shall become fully rewritten herein; and be it further

RESOLVED, that the provisions of this resolution shall remain in full force and effect unless otherwise provided for by the said Board.

1. Effective January 1, 2023, the Plan is correcting the language for the High-Cost Prescription Drugs on the list of services that require precertification under the Medical Management Services in Section III. Health Care Benefits as shown below.

III. Health Care Benefits

Medical Management Services

What other services require Pre-Certification?

- Monthly high-cost Prescription Drugs that are \$1,000 or more and are:
 - o Injectables.
 - o Infusion therapies.

High-cost Prescription Drugs are drugs that are covered under the medical benefits section of the Plan.

All other provisions of this Plan shall remain unchanged.
