*WHEREAS*, James A. King, Insurance Consultant, recommends that the Wood County Employee Health Benefits Plan Document, as approved on January, 17, 2006, via Resolution number 06-129, be changed to expand the prescription drug benefits schedule of benefits for over-the-counter medications, and

*WHEREAS*, Dr. King further recommends that expanding the schedule of benefits will keep pace with the marketplace to provide lower cost drugs to the plan participants while saving the plan health care dollars, and

*WHEREAS*, the plan amendment, included as Attachment A, is supported by the Employee Health Benefits Committee and is submitted for Board approval, and

*WHEREAS*, the Board has considered the recommendations presented on behalf of the Dr. James King, the Board concurs with said recommendations; therefore, be it

*RESOLVED*, by the Board of County Commissioners of Wood County, Ohio, that effective August 1, 2011, that all the plan amendment, listed as Attachment A, shall be authorized to modify the Wood County Employees Health Benefits Plan Document; and be it further

*RESOLVED*, that said Attachment A shall become part of this resolution as if rewritten herein, and that the provisions of this resolution shall remain in full force and effect unless otherwise provided for by the said Board.


