Any balance remaining at the conclusion of a case shall be refunded.

** Subsequent motions include all motions filed after a case has been opened or re-opened and remains pending and can include, but not be limited to, counterclaims, crossclaims, motions to show cause, motions for immediate relief, and discovery related motions.
